From inception in 1999 to 2014, we provided 22,587 low-income people with financial education and business development services to help them start and grow businesses and build net worth.



60% of our clients are women.
73% of our clients' businesses have received AnewAmerica green certification.

We welcome clients from all over the San Francisco Bay Area, providing training and counseling in Berkeley, Oakland, Concord, Richmond and San Jose.



Our clients come from 52 countries around the world.



We have helped 728 clients start and expand a business and create 968 jobs.



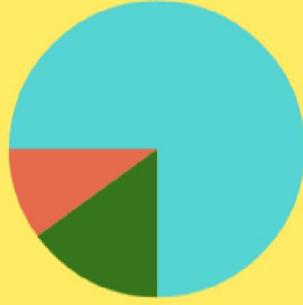
556 of our clients started their business from scratch.
